Within the My Account Information area there are three sections.

**My Account** enables members to change or update contact information instantly, update e-mail addresses, change their passwords, and conveniently maintain their most current contact information in The Transplantation Society membership database. Members can choose to use this new e-mail address as their primary address, or they can connect this new address to their existing personal or professional e-mail address. # New awards and fellowships on the horizon

The Transplantation Society is enthusiastically instituting a number of new awards in 2005/2006. Through these new awards, The Transplantation Society will recognize individuals who have made significant contributions to the field of transplantation within the past five years.

"This is an exciting new initiative to recognize members who are defining new directions in transplantation research and clinical development ," says TTS President Kathryn Wood.

Among the other initiatives TTS is considering under the theme "New Directions," are research fellowships and training scholarships. The research fellowships would be high profile two-year grants offered to either scientists or clinicians to enable members of TTS to acquire skills in research—a minimum of two fellowships per year would be offered in the first instance. The Society is investigating outside funding to assist with costs, and anticipates naming the awards after a major funder. As the program develops, TTS would hope to be able to offer a Research Fellowship to a member from each region of the Society every year. The Executive Committee is also working towards instituting international training scholarships to enable members to acquire new clinical or research skills. This program will be developed in collaboration with the Global Alliance for Transplantation and will be offered to TTS members from each of The Transplantation Society's six regions.

TTS Executive Committee met for two days in December and holds regular conference calls. The new Committees are also hard at work and will report to you regularly. Two immediate highlights from the Committees are:

Prof. Kathryn Wood

**TTS Ethics Committee**, under the leadership of Frank Delmonico, is organising a second Forum in the series to establish Guidelines for the Medical Care of Living Donors, to be held in Vancouver, September 2005. The Forum is a collaboration among TTS, IPITA, and ITA (Sections of TTS); the ILTS and the ISHLT.

**TTS Education Committee**, chaired by Nicholas L. Tilney, is developing slide sets from selected speakers at the successful Early Morning Courses at the Vienna Congress. Slides from Thomas Wekerle and Bruno Watschinger's Basic Science course, and Rainer Gruessner and Enrico Benedetti's New Technologies and Surgical Techniques course are available now on the Members Only section of the Society website. The Education Committee is also supporting the Society's efforts to become an accredited provider of CME credit.

Phil Dombrowski has instituted a monthly update to keep all Councillors abreast of the Society's activities. ### The Transplantation Society The Young Investigator Award for 2004

The 11 recipients of the Young Investigator Award in 2004 submitted abstracts to the XX International Congress of The Transplantation Society, and received the highest scores from an international panel of reviewers. The award has been made possible by the generous support of Fujisawa since 1994. The Transplantation Society is pleased to profile two Young Investigator Award recipients in each issue of *Society News* for 2005.



#### Dr. Mona Doshi

Dr. Mona Doshi received the Young Investigator Award for her paper titled Short and long term outcome of liver transplants from donors deceased after cardiac death (dcd). This research, part of her transplant nephrology and clinical research fellowship at the University of Iowa, showed an equivalence between livers donated

following cardiac death and those donated following brain death. This research may serve to expand the viable donor pool for kidney and liver transplants. Dr. Doshi is also studying the impact of current screening and treatments for cardiovascular disease among dialysis patients. Dr. Doshi says receiving this award from TTS "provided me an opportunity to present my work at the international meeting and get invaluable feedback from colleagues. As a result ... I have been able to make contact with people doing similar work and exchange ideas."

A graduate of G.S. Medical College in Bombay, Dr. Doshi completed her residency training at Wayne State University in Detroit, Michigan, and nephrology fellowship at the University of Chicago before beginning her current transplant nephrology and clinical research fellowship at the University of Iowa. Captivated by the intellectual challenge of nephrology, Dr. Doshi plans to explore the impact of pancreas transplant on other diabetic complications after completing this fellowship in the fall of 2005. She looks forward to bringing the results of her research to the development of health policies that may improve patient survival for people on dialysis.



#### **Dr. Angela Webster**

Dr. Angela Webster received the Young Investigator Award for her paper titled Incidence, risk and predictors of cancer after renal transplantation; an analysis of ANZDATA, the Australia and New Zealand dialysis and transplant registry. The research focuses on the impact of immunosuppression

in patients with end stage renal failure, the risk and predictors of cancers after transplantation, and exactly how different combinations of immunosuppressive agents might modify these risks. "I felt that both patients and clinicians would benefit from a clearer estimation of risk, tailored to their individual situations." Dr. Webster also hopes her work might lead to better treatment choices and also offer insights into cancer in general.

Currently working on her Ph.D. studies into *immunosuppression* and malignancy in end stage renal failure (due to be completed in 2006), Dr. Webster received her initial physician training in England and Scotland. She became a member of the Royal College of Physicians of Edinburgh in 1998. Interested in how other health care systems functioned, particularly in respect to renal medicine, Dr. Webster approached Westmead, the largest teaching hospital in Australia, and was offered a clinical post for one year in 2001. Four years later, Dr. Webster is still at Westmead's Centre for Kidney Research in Sydney, enjoying the benefits of being part of a large and active research unit.

#### International Pancreas and Islet Transplantation Association (IPITA)

Of interest at IPITA is the 10<sup>th</sup> Congress in Geneva (see Upcoming Meetings and Events). We hope to welcome you to this important event designed for scientists, physicians, laboratory technicians, and graduate students seeking the most up-to-date developments and procedures in the field of islet isolation.

Immediately preceding this meeting will be the International Islet Isolation Workshop of the Network of Islet Centers in Europe (NICE—see Upcoming Meetings and Events). Because of the involvement of and high-quality lectures by the leaders of the islet isolation and transplantation labs in Europe and North America, this has become an important annual event.

Registration will soon be available at www.ipita2005.org. Please note that the NICE workshop is independent from the IPITA meeting, and that registration to the IPITA meeting does not include the fees for the NICE workshop.

#### Intestinal Transplantation Association (ITA)

ITA would like to draw readers' attention to its upcoming meeting June 30–July 2, 2005 in Brussels (see Upcoming Meetings and Events). Participation is expected from a wide variety of specialties including gastroenterology, nutrition, anesthesia, and surgery from all over the world.

Progress in intestinal transplantation will be presented as well as a summary from the world registry. Much lively discussion is expected, as has been the tradition in previous meetings. This meeting will also elect the first president and officers of the association.

#### International Xenotransplantation Association (IXA)

The IXA2005 Congress, September 11–14, 2005 in Göteborg, Sweden (see Upcoming Meetings and Events), will be preceded by a one-and-a-half-day satellite meeting, entitled *The 2<sup>nd</sup> International Symposium on ABO Incompatibility in Transplantation*. Designed to complement the main meeting, it will be held September 10 and 11. The satellite will focus on the clinical aspects of ABO incompatible transplantation, a subject that has gained considerable attention the last few years, driven by the increasing global shortage of organs for transplantation. A number of wellrecognized plenary speakers will lead the proceedings, but participation and submission of abstracts within this area of interest from the wider community is encouraged.

## International Society for Organ Donation & Procurement (ISODP)

Mark your calendars—December 3–7, 2005. The final preparations are being made for the 8<sup>th</sup> Congress of the ISODP in Gramado, Brazil. It will be a joint congress with the ITCS-the International Transplant Coordinators Society. Among the keynote speakers are Stewart Youngner, Nicholas Tilney, and Francis Delmonico. #### **Cell Transplant Society**

Thanks to the support of industry (17 companies) and registrants, the Cell Transplant Society Congress in Boston last November was a great success. The 350 Congress delegates came from 25 countries to hear 61 invited speakers. The Congress is pleased to remit a donation of \$25,000 US to the Cell Transplant Society. The next Congress of the Cell Transplant Society is planned for Milan, Italy, in 2006.

The Cell Transplant Society exists to promote research and collaboration in cellular transplantation. The research interests of members include pancreatic islets, bone marrow, endothelial, epidermal, myoblast, neural and stem cells.

Investigators of cell and tissue transplantation share problems and research targets on topics such as separation techniques, culture methods, cryopreservation and banking, pretransplant immuno-modulation, micro-and macro-encapsulation, bioartificiality, tolerance, xenografts, quality control, implantation sites and techniques, experimental and clinical transplantation, and gene therapy.

The Executive Committee has also recommended initiating two Research Support Grants—the Transplantation Research Support Grant and the Transplantation Proceedings Research Support Grant—named for two of the Society's official publications and financed up to \$10,000 by contributions TTS has received from each of these publications.

A new "Emerging Stars Award," also proposed by the Executive Committee, would address the difficulty in identifying future key opinion leaders—researchers who may be finishing training and whom their mentors regard as having the potential to make a significant contribution to the field in the future. A series of small regional meetings would identify researchers at mid-level experience. Up to 25 nominees would attend the meetings along with a senior staff person from their organization to present their research

## The Transplantation Society's new logos

The second logo is bolder and more compact, using the abbreviation "TTS" for The Transplantation Society, while continuing to utilize the familiar circle and the clasped hands. This logo will work well in situations where TTS places its logo alongside other logos. In these cases, the bold "TTS" will be more noticeable and afford better on-going recognition for the Society.

The "1966" shown within the circle in both logos states the year TTS began and is a reminder of both the longevity and sustainability of this organization. It also serves as a reminder that, in 2006, TTS and its members worldwide will celebrate our 40th anniversary.

## Dr. Paul Lacy


With great sadness and deep emotion we learned of Dr. Paul E. Lacy's death, at 81, on February 15. Paul Lacy will be rightfully remembered as the father of islet transplantation, thanks to his pioneering work since the 1960s in this then novel approach to curing type 1 diabetes.

Paul Lacy performed the first successful islet transplant in a diabetic animal in 1972, and the first human islet transplant that enabled a patient with type 1 diabetes to stop using insulin injections in 1989. He was also instrumental in creating the Juvenile Diabetes Foundation, now the Juvenile Diabetes Research Foundation, in 1970.

For 23 years Dr. Lacy was a Professor and the Chairman of the Department of Pathology and Immunology at Washington University in St. Louis. After his retirement in 1984, he continued to consult with researchers working in the field of islet cell transplantation. He will be missed and remembered as a gentleman and a pioneer in times when islet transplantation was a scientific frontier.

Many delegates to the 10<sup>th</sup> World Congress of IPITA in Geneva this Spring undoubtedly owe much to the extraordinary

**My Orders will** provide members with the opportunity to make secure purchases or payments for everything from journal subscriptions to membership fees. The site will maintain a confidential history of these transactions for members to access at any time (their own transactions only). No more looking for lost receipts for business expenses—just log in and print a new copy. All amounts displayed on the TTS website are shown in US dollars.

The **E-mail notifications** page will allow members to subscribe or unsubscribe to all the newsletters and updates available from TTS. Members can also view a list of their current subscriptions to verify their selections.

#### **Document Review**

A new feature just added to the Members Only section of the website, this section will enable authors to invite selected members to review and comment on documents. Using this database-driven function, an author will upload a document to the site. The author then selects the members he/she wishes to ask to review the document and crafts a message that is sent to those members along with a link to the page where they will find the document. Each reviewer can then log in, download the document for review, and see the comments of any previous reviewers. Once complete, the reviewer simply uploads the document again, with his/her comments.

This is a sequential process. When one member downloads the document, the database puts a lock on the file so it cannot be accessed until that reviewer has either completed the review and uploaded the document again or simply returns the document to active review without making any comments. The database will show who has the file at each stage as well as the date and time of the download. The author can, at any time, see the status of the document and download the completed reviews. To begin with, this will ease the review of papers, documents, policies, etc., by the Council, the Executive Committee, and the various Committees that are active within TTS.

#### **Online Forum**

This is a new bulletin board area where members can ask questions, read posts, or search for information provided by other members on the forum. All posts will remain accessible to other members. We encourage our members to make full use of this new feature of the Society website.

## FAQs at the CBO

We hope you enjoy this new regular feature of *Society News* for 2005. It highlights the most frequently asked questions (FAQ) that come into The Transplantation Society's Central Business Office (CBO). We feel that communicating the answers to these common questions through *Society News* will help all our members, as well as improving our service to them.

### **QUESTION:** I cannot connect to the journal *Transplantation* online

**ANSWER:** There may be two reasons for this. First, you may not have paid your dues and therefore the publisher has not yet been authorized to release a new access code. As soon as the CBO receives your membership payment, we will send notification to *Transplantation* within 48 hours. Second, your dues are paid and the publisher has sent you a letter acknowledging this, but you still cannot gain online access to *Transplantation*.

The reason here may be that you have not activated your account. Included in the letter from *Transplantation* is your 12-digit account number, which you must use to access *Transplantation* online. To activate your free online access to *Transplantation*, follow this procedure:

- Go to the
- website—www.transplantjournal.com
- · Click on Register
- Click on Activate Account
- Enter the 12-digit account number provided by the publisher
- · Enter your e-mail address
- · Click on Activate Account

QUESTION: I'm no longer receiving my journals

**ANSWER:** The simplest answer is that you may have forgotten to purchase or re-subscribe to the journals for the new year. However, if you have paid for your 2005 subscriptions, the journals ask for your patience as it may take the publisher six to eight weeks to send you your first issue. QUESTION: If I purchase the journals any time after the first of the year, will I receive back issues?

**ANSWER:** Yes. The Central Business Office sends a special letter to the publisher with your payment asking that all back issues be sent to you as soon as possible. Again, the publisher asks for your patience as it may take six to eight weeks to send you the back issues.
